The Association had filed in October 2023 before the Hon'ble Supreme Court of India, two Civil writ petitions bearing no. 1133/23 relating to the fixation of pension and aged related additional pension and bearing 1134/23 relating to the post retiral benefits to the hon'ble Judges of the Supreme Court and High Courts of India. The Association's advocate Arjun Garg, Advocate on record (Whatsapp No.9971796913) has informed that the rejoinders have been filed in both the Civil writ petitions and the writ petitions are likely to come up in the month of July 2024 and onward.
