(VI) to offer services of the members for effective and expeditious dispute resolution so as to assist the Courts/Organizations/Authorities at all levels for liquidating the colossal arrears of cases now pending adjudication at various levels throughout the country and (VII) To undertake all and whatever actions, steps or other proceedings including Public Interest Litigation for the realization of the objectives above mentioned.

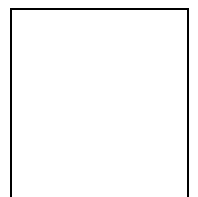
